He stated that he drafted a letter to Yates County Soil and Water to set up a meeting in September to discuss the agreement they have with the Town of Barrington. The Board discussed putting Griffin on full time in January for the Watershed at the same rate they are paying Yates County Soil and Water which is \$17,500. Wright stated that the pay rate will stay the same for the Code Enforcement and Watershed jobs but Griffin will be able to receive health insurance and the appropriate retirement.
