Supervisor Warren called the Town Board meeting to order at 7:00 pm with the Pledge of Allegiance.

#### 2. Approve Minutes

A motion to approve the minutes of 8-29-16, 9-6-16, 9-22-16, 10-4-16, 10-12-16, 10-26-16 and 11-7-16 was made by Olney and seconded by Warren.

## 3. Public Participation on Non-Agenda Items

Bruce Castner arrived at 6:02 pm

Seth Olney asked the Board if they took any further consideration for the offer that he made regarding 823A East Lake Road where he would withdraw the second half of the lawsuit if the Town Board would show support for his serving beer in the tap room area of his business to the State Liquor Authority.

Lange stated that the offer was denied. Crosby explained that they should be speaking to the Attorney and not to the Board at this meeting. Bryant wanted to know who made the decision. Lange let her know that it was done at an Attorney-Client meeting.

Seth Olney stated that it was an offer that he presented to the Town Board eight weeks ago. Seth stated that this is not arbitration; it's simply him speaking to the Board. Crosby reiterated that it's something that must be taken up with the Attorney.

Bryant stated that she wanted to point out that she foiled the Town's attorney legal bills and as far as she can see, as of yet there still hasn't been work done on responding on the merit of issues of preemption. She stated that she expects that it will cost at least another ten thousand dollars for the Town's attorney fees.

Fred Goosen of 1081 East Lake Road asked what the goal of the Board was to satisfy needs of both sides of this issue. Supervisor Warren stated that the Town Attorney suggested that the Town Board do not speak to the public regarding the litigation unless he is present.

Warren stated that the Board would like to see Seth Olney succeed but it has to be done on a legal basis. Warren stated that the main thing they are addressing is that there are no bars allowed in a lake residential area. Seth stated that there isn't a law that the Board can point to that he is breaking. He said that they can't site the code that they are using to penalize him. He further stated that they can write a letter to the State Liquor Authority harming his business and telling them that he is not allowed to be doing what he is doing. Seth stated that if he were to have a band out there at his business tonight there is no law that he would be breaking.

Chuck Tolbert asked the Board how new owners would be treated if they bought the Viking. Crosby stated they will have to go thru the same process as Olney.

Bryant stated that the Board could make a decision without consulting with the Town Attorney. Lange stated that they are trying to uphold the zoning law. She stated that there are no bars allowed in the lake residential district.

Supervisor Warren stated that the time is up regarding the Olney Place situation and there will be no more conversation regarding it at this meeting.

Seth Olney stated that James Shirk brought it to his attention that the Town is developing a new safety policy specifically around Mennonite schools. Olney stated that he heard there was going to be a letter written regarding the conduct of a certain employee and if so is that letter going to be available to the public. Warren stated that he did send a letter to the school. Olney asked who signed the letter. Warren said that he did. Olney asked if anyone else signed the letter. Warren said no.

Jessica Bryant stated that to her understanding John Griffin was reinstated pursuant to the executive session days after he was released from his position. She further stated that she understood that this reinstatement is for a temporary period of time and asked if that was true and if so is the Board in the process of determining whether someone else will be rehired starting January 1<sup>st</sup>. Warren stated that the Board will make that decision at the beginning of the year.

A motion to go into executive session to interview David Garrett for the Zoning Board of Appeals was made by Warren and seconded by Olney at 6:20 pm.

She explained that mileage paid from someone's home to their place of employment needs to be paid as part of their wages and not through mileage reimbursement. He read off some information given to him from the auditors. He read that no transportation costs will be allowed between any employee's place of residence and his or her official station. Warren read a letter from a realtor that has a client that may be interested in buying the Viking, but has concerns with the current "climate" of the Town regarding the Olney Place situation.
