**RESOLVED**, that the Town Clerk be, and she hereby is, directed to post a copy of the proposed Local Law on the Town of Barrington sign board and take any and all other necessary actions to properly bring the aforementioned Local Law before the Town Board of the Town of Barrington for its consideration; and be if further

**RESOLVED**, that the Town Clerk be, and hereby is, authorized to provide all other notices as required by law for the adoption of this Local Law.
