Supervisor Perry called the meeting to order at 6:00 pm with the Pledge of Allegiance.

Rob Schwarting and Sheila Burt of the Yates County Board of Elections gave an annual update. Schwarting will be retiring and he is recommending that Burt take his place. Burt stated that there have been several changes in election law. There are 21 bills right now that have been approved by the Senate and are waiting on the assembly. They are recommending that all voting sites have a backup generator. Wheeler stated that the Town is working on it. Schwarting stated that the Himrod voting site may be closed to save about \$6,000 a year. Everyone thanked Schwarting for all his service and wished him a happy retirement.

Wheeler stated that George Fisher of Fisher's Tree Service came and fixed the town flag pole pulley for free.

Jesse Jayne gave his monthly report to the Board. He stated that the month has been very busy with building permits and inspections. He further stated that he has gotten good results getting more cars moved that have been an issue.

Supervisor Perry stated that he received a message to call Delahunty. He stated that he called and left him a message but Delahunty never called him back. Perry asked where the situation stood regarding his request to cut the guardrail on East Lake Road because Delahunty has not attended anymore meetings. Last he knew they were still waiting for a stamped plan. Wheeler stated that they can not move forward on anything until Delahunty has an engineered stamped plan for that guardrail. He can not use the generic plan that he brought to the meeting previously.

Wheeler stated that he seen him on East Lake Road and asked Delahunty where the plans were and that they were waiting on him. Petro asked what his response was. Wheeler stated that he said he was working on it.
