Permit Request Description Permit a sign to identify the "Skelly Properties", including "Yurtin' on Keuka", "Wine Trail Covered Wagon", "Acres Away - Aframe", and a "Rustic Ridge Log Cabin" (not built yet) on eastern portion of Sturdevant Road, at the intersection with NY State Route 54. The sign will be on the Town of Barrington property and must approved by the Town's Highway Supervisor but will not be in the Sturdevant Road's right-of-way. The location will be inspected by Town's Highway Supervisor and the Applicant.

The sign will be supported by three (3) 4x4 posts and will be a maximum 6.25 ft. wide by 10.5 ft. tall (64.4 sq. ft). The sign will be one sided and facing south.

The sign will be lit by two (2) solar lights that will come on at sunset.

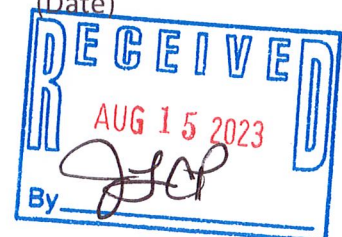

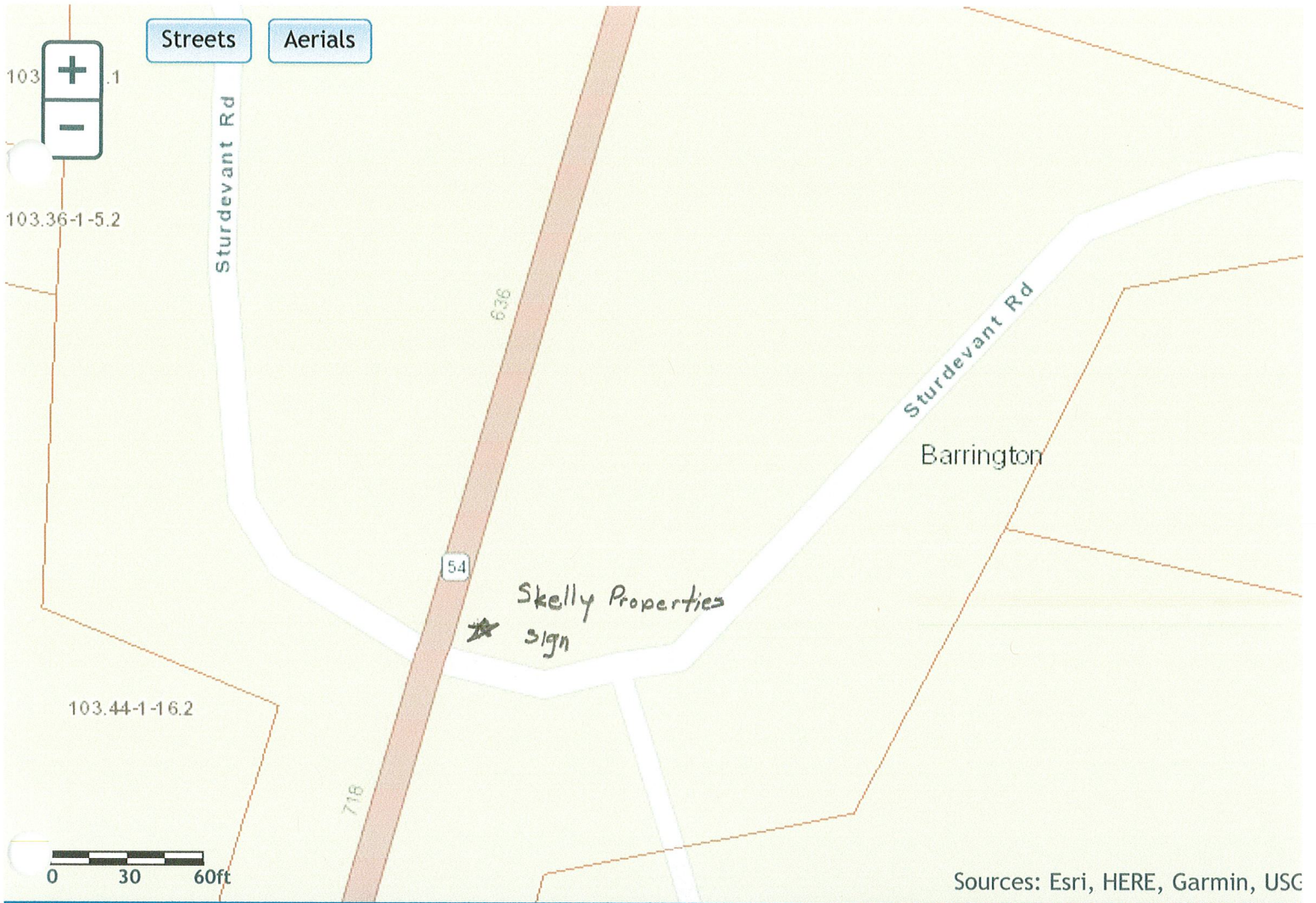
