Supervisor Perry presented the Board with an agreement from Yates County and Water for septic inspections in Barrington. The Board is concerned that the agreement places the responsibility of handling violations on to the Town Code Enforcement Officer. The Board feels violations would be handled by Yates County Soil and Water because they have the technical knowledge that would be needed in any legal proceedings. The Board tabled the agreement and will be reaching out to Yates County Soil and Water to discuss it.
